A Resolution Honoring Richard C. Fyffe

Whereas the Association of College & Research Libraries and the broader community of academic and research libraries and librarians lost a valued member, mentor, and leader on November 5, 2015, with the death of Richard C. Fyffe, Samuel R. and Marie-Louise Rosenthal Librarian of the College at Grinnell College;

Whereas Richard C. Fyffe provided leadership with distinction for academic libraries in the United States for over 30 years, including Grinnell College, the University of Kansas, the University of Connecticut, the Essex Institute and the American Antiquarian Society;

Whereas, Richard C. Fyffe provided leadership for the Grinnell College Libraries that resulted in their being awarded the \_\_\_\_\_ (College Library Category) by the Association of College and Research Libraries in 2011;

Whereas Richard C. Fyffe made important contributions to the literature of academic librarianship for over 30 years in areas such as archives, collection management, scholarly communications, and library leadership, including receiving the Blackwell Scholarship Award and "Best of LRTS" Award in 2003 for his article "Technological Change and the Scholarly Communications Reform Movement: Reflections on Castells and Giddens," published in \_\_\_\_\_, April 2003;

Whereas Richard C. Fyffe served as a valued member of the editorial board of the leading publication in academic librarianship, \_\_\_\_\_;

Whereas Richard C. Fyffe served as Chair of the Board of Directors of the Center for Research Libraries in 2013-14 and a member of the Center for Research Libraries Board of Directors from 2010 until his death, Chair of the ACRL Scholarly Communications Discussion Group (2002-2005), Co-chair of the ACRL Scholarly Communications Committee (2008-2010), Chair of the Coordinating Committee of the Oberlin Group: A Consortium of Liberal Arts College Libraries (2011-12);and
